Monday morning started off with a continental breakfast and a brief update on current issues with Ohio Department of Health. Followed by a full schedule of speakers including: Ken Klopecki from M.A. Step, who spoke on step safety, Tim Chylik of Carmeuse and his topic of discussion, was Engineered Limestone, Several Admixture representatives were on hand for a panel question and answer period including: Steve Allender, representing SIKA, Mike Wojt from Chryso, Inc., Jesse Osborne from Euclid Chemical, Joe Daczko, BASF and Jim Kolakowski from Grace Construction Products. Also, there was an ODOT Specifications discussion led by Mike Hoffman from Lindsay Concrete Products.

The attendees then traveled

to Canal Fulton to the Lindsay Concrete Products facility. And after lunch, provided by Lindsay/OPCA, we broke into several groups and were given a tour of their plant.

Private Sector Jobs: Decade in Decline

According to U.S. Labor period. The 22 states Department Bureau of Labor Statistics (BLS) data, between the year 1999 and 2009 more private sector jobs were lost in that decade than since the Great Depression. In 1999 statistics showed roughly 108.32 employed in the private sector as compared to 2009 statistics of 107.95. A difference of 370,000. However, there is some news worth taking notice on. An overwhelmingly

majority of the 22 states with Right to Work laws in effect, showed growth in that same decade. Private sector employment for these states was up roughly 1.5 million during this

with Right to Work laws are as follows: Alabama, Arizona, Arkansas, Florida, Georgia, Idaho, Iowa, Kansas, Louisiana, Mississippi, Nebraska, Nevada, North Carolina, North Dakota, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, and Wyoming. The remaining 28 states collectively during this period lost 1.9 million private sector jobs. Ohio being among them. Unfortunately, despite the unemployment figures and economic hardship resulting in most businesses' lingering inability to hire more

workers, most of Congress and the President seem to be heading in the wrong direction. Case in point, the ironically labeled "Employee Free Choice Act" which isn't freedom at all. Would allow unions to gain control over millions of additional private sector workers.

Please watch out for any additional information coming your way. Also Keep informed with what your Senators and Representatives both National and State have been voting on good or bad. Remember, your vote does count when it comes to Election Day!

Mr. Haman, in partnership with his bride, Carolyn, founded Concrete Sealants, Inc. in 1970. In the beginning, every member of the Haman family participated in the operation of the company. In 1996 Bob and Carolyn sold the business to their daughter and son-in-law, Cindy and Howard Wingert who are continuing the Haman legacy.



In a show of their appreciation to the Wingert family, the employees honored Bob's memory with an inscribed plaque, a tree and flowers at the entrance to the offices of the Tipp City, Ohio plant. The plaque, with a photo etched in granite, bears the phrase that has become the company motto: "Who do we work for? The customer." It is a statement that Mr. Haman created early in the company history. It is a motto that still lives today. Howard Wingert said it best, "Mr. Haman was a mentor and a friend, and we will miss his wit, charm, and intellect always".

The plaque, along with the concrete foundation supporting it was manufactured by Spoerr Precast Concrete in Sandusky, Ohio.
